City Council Minutes
Regular City Meeting
Council Chambers
October 10, 2019 at 7:00 PM

Present: Mayor Brenda Moore; Councilwoman Ashley Stewart; Councilwoman Brandie Wilson; Councilwoman Bonnie Manning; Councilman John Campbell; Councilwoman Danielle Wood; Councilwoman Evelyn Saldana; City Clerk, Debbie Batliner; City Attorney, David Clement; Code Enforcement Officer, Rick Nelson; and Chief of Police, Jim Sherrard.

Mayor Moore called the meeting to order at 7:06 PM.

A motion to approve the minutes of September 12, 2019 was made by Councilwoman Ashley Stewart and second by Councilwoman Evelyn Saldana. Councilwoman Brandi Wilson was absent for vote. Vote was unanimous.

Discussions were held regarding the delinquent property taxes. Collections for delinquent property taxes stands as is.

Resident on Selma Avenue wants to know about the sidewalks on Selma, light and drainage issues. Mayor Moore stated that we could not do sidewalks and road projects until MSD gives us the approval. Mayor Moore also stated that we would have to have the number off the pole to be able to take care of the lighting.

A motion was made by Councilwoman Bonnie Manning and second by Councilwoman Brandie Wilson to accept Resolution 2019-001 authorizing the City of West Buechel to enter into a Franchise Agreement with MCI Metro Access Transmission Services. Vote unanimous.

A motion was made by Councilwoman Brandi Wilson and second by Councilwoman Danielle Wood to purchase a safer van for the community center by spending no more than \$30,000.00. Vote unanimous.

Department Reports:

Community Development: The Community Center Director has submitted a Policy and Procedures for the Afterschool Program and all forms which need to be reviewed by legal counsel.

Police Department: Chief Sherrard reported that there would be a Fall Festival on October 26, 2019 from 1-7 PM and all proceeds would go to the Shop With A Cop program.

Code Enforcement: Code Enforcement Report was included in packet. If you have any questions or concerns, please direct them to Rick Nelson.

City Clerk Batliner:

Gave a report on the financial status for the City of West Buechel. The capital outlay of \$90,000 with all departments included was not spent just on City Hall. A motion was made by Councilwoman Brandi Wilson and second by Councilwoman Evelyn Saldana to approve the financial report. Vote unanimous.

Mayor's Report:

Mayor Moore thanked everyone for their support. She also noted that MSD would set a starting date on Wednesday. Mayor Moore read a letter from the City's insurance carrier giving support of the City for changes over the last few months.

A motion was made by Councilwoman Danielle Wood and second by Councilwoman Bonnie Manning to adjourn the meeting at approximately 9:00 PM. Vote unanimous.
