Regular Council Meeting Minutes

Present: Mayor Moore, Attorney Keller, Attorney Hall, Councilwoman Cook, Councilman Bierbaum, Councilman Embry, Councilwoman Blanton, Councilwoman Wood, City Clerk Batliner, and Assistant Clerk Brown.

Absent: Attorney Keller, Councilwoman Saldana, and Councilwoman Manning.

City Clerk Batliner confirmed that we had a quorum.

Mayor Moore called the meeting to order at 6:30 PM.

Minutes:

A motion was made by Councilwoman Cook and second by Councilman Embry to approve the minutes of October 12, 2023 – Regular Meeting. Motion carried unanimously.

Attorney Hall read the first reading of Ordinance 310 Series 2023 pertaining to the Code Enforcement Board. There was discussion about when the trash bins should be placed on the road for pick-up and when they should be removed after trash pick-up. Councilwoman Wood sponsored the ordinance as read.

Department Reports:

Police:

Assistant Chief Hibbs suggested that city hall mail out flyers to new residents letting them know what to expect and what not to expect in the neighborhood. Assistant Chief Hibbs noted that even when he and Chief Tyler were out for training, our police department continued to work diligently in making sure the city was safe. The officers now have body cameras and can be monitored by Chief Tyler and Assistant Chief Hibbs. Mayor Moore thanked the police officers for all of their hard work they do to keep the city safe.

Financials:

City Clerk Batliner stated that 2 months of financial reports will be provided at the December council meeting. Mayor Moore reminded the council that the auditor is working on having the audit finalized to present at the December council meeting.

Mayor's Report:

Mayor Moore mentioned the current road work on Hikes Lane and on the bypass ramps.

Committee's Report:

Councilwoman Cook stated that the Multipurpose Center Committee did not have a meeting last month due to not having a quorum. Councilwoman Cook spoke about sending out postcards on November 24th, letting the

residents know about the Holiday Banquet on December 9th. Councilwoman Cook stated that they are working on the shop with a cop that is coming up in December.

City Clerk Batliner asked if she could give an update on the 501 3(c). Councilwoman Cook replied that they have the FEIN. City Clerk Batliner stated that the tax exemption has been applied for and we are waiting on the final letter.

Mayor Moore recognized the Veterans and thanked them for their years of service.

City Clerk Batliner and Attorney Keller are working on a policy on how the money is to be spent.

Adjournment:

A motion to adjourn the council meeting at 7:33 PM was made by Councilwoman Blanton and second by Councilwoman Wood. Motion carried with a unanimous vote.
