Department Reports:

Police:

Mayor's Report:

Mayor Moore conveyed that MSD is working on Roosevelt and Old Shepherdsville Road. Councilman Embry explained to Mayor Moore the drainage issue he is having on his property. Mayor Moore stated that if a resident has an issue that is a MSN concern, you need to speak with them directly.

Mayor Moore is very thankful for the ongoing MSD project in the city of West Buechel and all the work MSD has done over the past 5 years.

Mayor Moore stated that she was awarded the Lead Award from KLC from the Ann Deatherage Scholarship fund. Other awards were also received by others in the city. The awards are posted on our website or KLC for everyone's viewing.

Mayor Moore updated the council on the city hall repairs from the damage we endured during the 2022 freeze in December.

Committee's Report:

Councilwoman Cook stated that the Multipurpose Center Committee did not have a meeting this month. Councilwoman Cook shared a newsletter the committee developed to distribute to the residents outlining the events happening at the Multipurpose Center for the remainder of the year. An updated newsletter will be sent out because the holiday dinner is on December 9th not in November. The updated newsletter is on the website.

Councilwoman Wood asked if game night could be added to the newsletter. Councilwoman Cook stated yes. Councilwoman Cook clarified that game night is the 3rd Wednesday of each month.
