Department Reports:**Police:**

Chief Tyler provided the police department report in the council packet. Assistant Chief Hibbs spoke about the crime in the 6th district. Councilwoman Blanton thanked the police department in their part with monitoring the bus stop and help with moving the bus stop to a safer location.

Financials:

A motion was made by Councilwoman Cook to approve the June and July financial reports and second by Councilwoman Blanton. Motion carried unanimously.

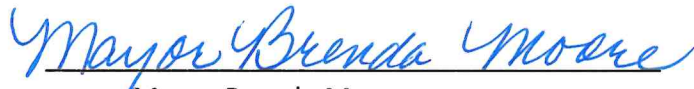
Mayor's Report:

Mayor Moore spoke about the new fence that was installed 2 months ago behind the police department, and someone had already driven their vehicle through it. Mayor Moore stated that Mr. Webster had applied for an abatement grant to help clean up the city. Unfortunately, we were denied due to a 2008 abatement grant that was not completed and the city had to pay back \$821.34 to be compliant.

Mayor Moore noted that Mr. Webster has applied for playground grants. One vendor can award the city a (55%) 55 percent discount on the playground equipment, and this grant offer expires in December. We are waiting for a response from T-Mobile Hometown Grant which could award the city with a \$55,000.00 grant and another one from Churchill Downs Grant which would be \$20,000.00. No grants have been awarded at this time.
