Attending: Mayor Moore, Councilman Clark, Councilwoman Stewart, Councilwoman Cook, Councilman Embry, City Clerk Batliner, City Attorney Hall and Assistant City Clerk Brown.

Mayor Moore asked City Clerk Batliner if we had a quorum. City Clerk Batliner confirmed a quorum was present. Mayor Moore called the meeting to order at 4:32 PM.

Mayor Moore asked City Attorney Hall to read the Change in Meeting Time Ordinance.

City Attorney Hall read the Ordinance 300 Series 2022 pertaining to a Change in Meeting Time. Motion to approve Ordinance 2022-300 was made by Councilman Embry and seconded by Councilwoman Stewart. A roll call vote is as follows: Councilwoman Stewart, yes, Councilman Clark, yes, Councilwoman Cook, yes, and Councilman Embry, yes. Motion carried unanimously.

Mayor Moore asked City Attorney Hall to read the Mayor's Proposed 2023 Budget Ordinance.

City Attorney Hall read Ordinance 301 Series 2022 for the second reading pertaining to the Mayor's Proposed 2023 Budget. Motion to approve Ordinance 2022-301 was made by Councilman Embry with the caveat that the ARPA funding be used to fund police services. This motion was seconded by Councilwoman Cook. No objection was made by any council member to Councilman Embry's motion and a roll call vote on the ordinance was taken and voted on as follows: Councilwoman Stewart, yes, Councilman Clark, no, Councilwoman Cook, yes, and Councilman Embry, yes. Vote 3 to 1. Motion to approve Ordinance 2022-301, therefore, passed.


Closed Session
